Student Regulations

Commitment:

1. Every student would observe the basic university system and the related regulations.
2. The student would know the rules of the university, and committed to what is stated therein and responsible for violating any of its provisions.

First: Regulations Concerning Commitment:

- a. Student must obtain the approved university card according to which he / she is entitled to enter the university, attend lectures, enter the examination rooms and benefit from the library.
- b. Complete registration procedures, pay tuition fees and all data at the specified time and accurately.
- c. Full-time commitment to study for regular students.
- d. Commitment to the proper dress and the overall appearance of students inside and outside the college and the suitable dress of female students'
- e. Commitment to conduct and respectful behavior towards lecturers and university staff.
- h. Do not insult religions and beliefs and avoid useless arguments.
- f. Attending lectures discussions, tests, examinations and all forms of teaching as determined by the various scientific regulations and programs.
- g. Commitment to behavior and good attitude in classrooms, laboratories and university campus.
- i. Take care of university properties.

- k. Respecting the sanctity of places of worship.
- l. Respecting the laws and regulations prevailing in the country, and fully abide by all laws and regulations that lead to achieving the mission of establishing the university.

Second: The list of what should be avoided (irregularities):

- a. anything that disrupts public order.
- b. Disruption of study or incitement to it or refrain from attending lectures or lessons and scientific experiments due to students.
- c. All acts which are contrary to honor or violate good conduct inside and outside the university.
- d. Establishing any illegal or unauthorized activity within the university.
- e. Distributing of leaflets or issue of wall, cultural or political newspapers or collecting signatures without the prior permission of the university's authorities.
- f. Any violation of the rules of examinations or the initiation thereof.
- g. Picketing at university buildings or participate in demonstrations contrary to public order and good behavior.
- h. Bringing or making any kind of weapons or anything (for the purpose of being used as a weapon) within the university.
- i. Possession, manufacture or consumption of any kind of spirits or other narcotic substances or drugs and stimulants.
- k. The student's practice of any profession or activity is not morally appropriate and his status as a student at the university.
- l. To bring an act or speech that affects his reputation as a student of a scientific institution within or outside the university.

Third: The Penal Code:

- (1) Any person who contravenes all or some of these regulations would be punished by one of these penalties:
- a. drawing attention orally or in writing.

- b. Warning.
 - c. Denial of certain activities (social cultural sports) for a specified period or permanently.
 - d. Denial of the attendance of some courses for a period not exceeding one month.
 - e. Suspension of study for a period not exceeding one month.
 - f. Two or more penalties may be added in case of damage to university properties or private properties.
 - g. Stop studying at the university for one year.
 - h. The final dismissal of the university, in this case the decision would be communicated to the other universities.
- 2 / the decision of the penalty may be announced within the university.
3. Transfer the decision to the student's guardian.
- 4 / A copy of the decision are saved in the student's file.
- 5 / Dean of Students' Affairs from his turn to apply penalties listed in items (a) to (g).
- (6) The penalty stated in (h) of the competence of the Vice chancellor.
- 7 / Punishment stated in (h) of the competence of the Vice chancellor subject to the approval of the board of senate.
- 8 / The student has the right to defend himself in front of the questioning Council, as he wants.
- (9) Penalties (b) to (d) shall not apply to the student until after the student has been investigated and heard in what is attributed to him in a written record signed by the student after being informed of him. If the student does not appear before the committee at the time and place specified for the investigation, prior to his or her failure, the right to speak or defend himself.
- 10 / The Board of Questioning, formed by the Dean of Student's Affairs, in accordance with code (7) of the Penal Code, shall decide on the

penalties provided for in code (d) and its decisions shall be in force once they are issued and shall be conclusive and final upon ratification by the Vice chancellor.

Conclusion:

1. Since the University works in harmony between all its branches and specialized secretariats, everyone should assist in the implementation of the regulations that facilitate the work of each secretariat so as not to overlap (all responsible to the Rector).
2. The Deanship of Students' Affairs is the body entrusted with following up on the regulations concerning its work.
3. University Guard is a tool to implement the University's organizational policies must be respected and comply with its guidelines.
- 4 These regulations. Apply to Post graduate and continuous graduate students in the prevailing systems at the university except for the unified uniform.
